Call to Order

President Duarte calls the meeting together at 6:00 PM. Spanish translation is provided for this meeting.

Item 1.0 – Public Comment

• Licia Clark shares information on the summer Enrichment Program that starts July 8-25th for 5-11 years old. Anyone interested can apply.

- Meliton Vasquez- Requests traffic markings in the community to prevent cars

<u>Item 3.0</u> – Hold Public Hearing for the Adoption of the 2024-2025 District Proposed Budget

The Board of Directors held a public hearing prior to the adoption of the 2024-2025 Proposed Budget. The following procedure was followed for this public hearing:

- A. Open Public Hearing
- B. Presentation by Elaine Cervantes, General Manager
- C. Public Comments
- D. Close Public Hearing
- E. Board Discussion.

The Board President opened the public hearing at 6:17 PM. General Manager Elaine Cervantes presented that the budget has remained unchanged since 2018, with the same categories and four part-time employees. In 2021-2022, an audit revealed a deficit of over \$37,000, and a report on this is available. The previous board was aware of this issue. She acknowledged that communication, especially in Spanish, needs improvement. However, including interpretation services in the budget will incur additional costs. The District has not charged late fees for customer bills since COVID-19. Notably, a large amount of customers do not pay their bills. Since 2021-2022, the District has been operating with a deficit.

After her presentation, public input was received. Complaints highlighted issues with budget transparency and accessibility, including the lack of documents in Spanish, unclear financial changes, the need for audits and workshops, better access for non-tech-savvy individuals, posting information on doors, including linguistic translators in the budget, and concerns about high bills and overspending.

The public hearing closed at 7:15 PM.

<u>Item 4.0 - Approval of the 2024-2025 District Budget</u>

Public input was received, with many comments urging against approving the budget as it currently stands. The board of directors then deliberated among themselves.

The board has decided to table this item until the July agenda. They will return with detailed information and provide it for the public during a Special Meeting, with interpretation services available in Spanish.

Item 5.0- Public Hearing to Consider the Water and Wastewater Sewer Rates

The Board of Directors held a public hearing prior to considering the approval of water and wastewater rates. The following procedure was followed for this public hearing:

- A. Open Public Hearing
- B. Presentation by Dan Bergmann, Rate Consultant
- C. Public Comments
- D. Close Public Hearing
- E. Board Discussion.

The Board President opened the public hearing at 7:47 PM. Rate Consultant Dan Bergmann presented the item, stating that 7% of customers aren't paying their bills and it has been 10 years since the last increase. He mentioned that the District is moving away from the current tiered rates and emphasized that if the rates are not approved, the process will have to start over. This would mean incurring more costs, sending out another notice, waiting another 45-day period, the District going further into debt, and higher rates to cover the additional debt. The District would also have no money left and would need to do more public education.

Brian Pacheco, County Supervisor, was also present. He stated he represents the western portion of the county. In his 10 years as an elected official, he has brought \$7 million into the community by installing sidewalks and curbs. Brian introduced Amina Flores, Deputy CAO from the County, noting she is an expert in budget matters.

Public input was received, with complaints including a demand for Spanish translations on documents and in meetings, a need to actively seek grants, cutting unnecessary spending, highlighting the community's severe impoverishment, opposing the rate increase, and advocating for a fairer increase instead.

The public hearing closed at 8:56 PM. At the end of the hearing, Board President Duarte stated that 141 protests were received, which did not constitute a majority of votes.

Public input was received many comments they are aware the need for an increase, but at a fair amount. The board deliberated.
