Item 3.0 – Consider Awarding AM Consulting Engineers, Inc As the Selected Engineering Firm for CDBG Engineering Services

Elaine Cervantes, the General Manager, states the selection of AM Consulting, Engineers, Inc for the CDBG Engineering award marks a crucial step in the second phase of the Groundwater Recharge project. Following the issuance of a Request for Proposals (RFP) and the evaluation of two proposals, the expertise of AM Consulting, Engineers, Inc stood out, leading to their selection. Board Treasurer Madera highlights the cost-effectiveness of their rates, emphasizing that they are lower than those of the District's previous engineering firm.
