Hi Cruz,

As per our discussion earlier this morning, I am confirming the verbal approval for the temporary repair of the levee damage caused by the squirrels and storms. We had a quote from a contractor early last year to do the work for about \$44,000 for just the one levee. There are now three levees that are damaged. We plan on removing the damaged levees down to the pond bottom elevation and angling back the banks to help prevent further damage and costlier future repairs. We will do this work on a time and material basis and expect to be able to get it done in under 2 weeks, weather dependent.
